"First off was a trip to Texas on Saturday, January 13<sup>th</sup> where the chocolate sisters had the experience to trial in a covered arena. In the AM Lizzy struck gold and finished her run in 4:44, 16 seconds to spare, with 24 out of 27 points for a first-place finish. Maggie took 2<sup>nd</sup> with her run in 4:19 with 21 out of 27 points. In the PM, Lizzy placed 2nd, 1 second behind the first-place dog, she managed 26 out of 27 points on this run. Maggie placed 3<sup>rd</sup> with 24 out of 27 points. Their handler was very proud of the girl's performance on only 3 head of sheep in a very large rodeo arena."
